Enter information below to search the City's permitting database. Permits can be searched for by entering any of the following information:

You will typically be happy using **General Search**, although you can click the down arrow to display additional search options.

Since you are likely interested in how trees are being dealt with in the review process, you will select the Permit Type of **Arborist Plan Review**.

To reduce your search results, specify a **Start Date** (Note: the default is 10/01/2013, which will likely return many more records that you wish to see). You can type over the Start Date or click the calendar icon to select a start date (start with year, then month, then day). As user interfaces go, I find the specification of the date to be a bit clumsy, so be patient with it.

The default end date is the current date, but you can also alter that date, if you wish.

You can select **Quadrant** value of NE, NW, SE, SW. If you don't select, you get all quadrants.

The application only returns Atlanta results, so there is no need to specify any additional search criteria, other than **Zip** code, if you wish.



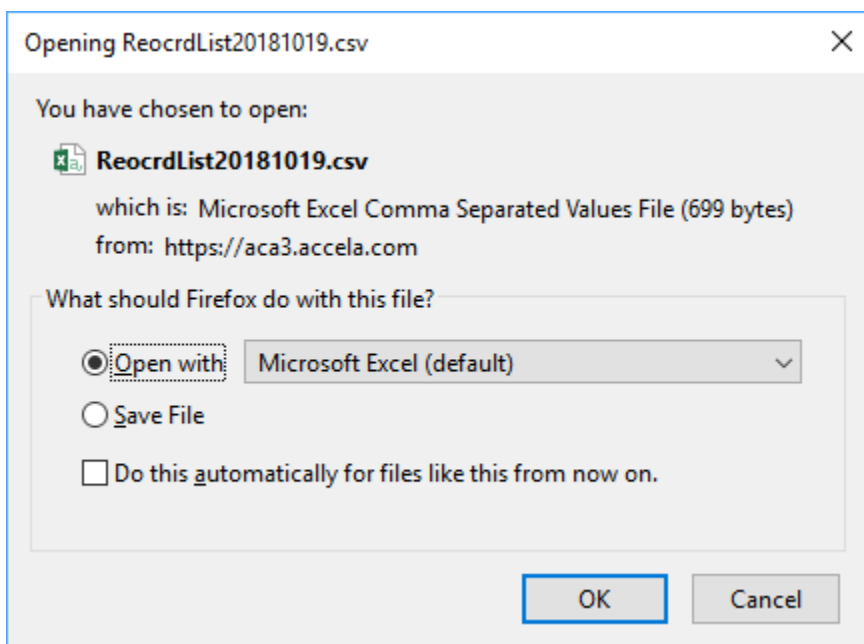
